Participants will be exposed to information designed to enhance their appreciation for the current and evolving landscape in conducting their business on the unceded, un-surrendered traditional lands of the Mi'gmaq, Wolastoqey and Passamaquoddy People.

A desired outcome for the Association is to begin the development of a respectful relationship with First Nations and their staff and organizations. The relationship would lead to a codification of mutual values and understandings in a Protocol.

Deliverables:

Advanced appreciation and understanding of the legal and social context for the relationship between Canada and the Indigenous peoples.

Participants will receive a certification of completion for the complete program, if they attend all 8 webinars.

Webinars:

A series of eight (8) webinars will be presented in two sessions (May 27-June 10 & September 9- October 7) in a Lunch and Learn format from 12:00-1:30 pm. The webinars will be facilitated by Tom Mann.

The goal is to establish a foundation of understanding and appreciation of the evolving business environment and the required relationship and engagement with First Nations and Indigenous communities and their leaders and staff.

Session 1

*June 3: Welcome to the Program and Overview of the Landscape:

With a welcome from Assembly of First Nations Regional Chief Roger Augustine a foundational introduction to First Nations of Wabanaki Territory, a brief historical perspective leading to the “new legal, constitutional and policy landscape will be featured. Introduction and warm up to the program.

*June 10: Reconciliation; A non-Indigenous person's perspective:
Presented by Don Ferguson*

One person's personal learning path about Indigenous Peoples and their history including their shared history with Canada and how that knowledge has shaped personal views and actions. Reflections on how each of us can make a difference in our search for Reconciliation with Indigenous Peoples.

*June 17: The Legal Framework
Presented by Tom Mann*

Probing into the landmark decisions of Canadian courts what are the legal obligations of the Duty to Consult? How is this Duty met? What is meaningful relationship building, engagement and consultation? A case study into Corporate-Aboriginal Relations in New Brunswick will be presented.

Presented by Chief Terry Richardson of Pabineau First Nations, CEO Denis Caron, Belledune Port Authority*

A how-to discussion on establishing and maintaining a mutually constructive process over the longer term and building trust in a complex and diverse environment. The discussion will delve into the alignment agendas to support successful projects.
